Payment of the 2021 annual company levy by 31 March 2022

- Electronic submission of forms for the withholding of Special Defence Contributions (SDC) and Cyprus General Healthcare System (CGHS) on Interest for the period 01/01/2019 – 28/02/2022 (IR602).
- Payment of tax deducted from employees salary (PAYE) in the preceding month. • Payment of Special Contribution for Defence (SDC) and contribution to General HealthCare System

Payment of Social insurance and contribution to General HealthCare System (GHS) deducted from

(GHS) withheld on payments of dividends, interest or rents (when the tenant is a company, partnership, the state or local authority) made to Cyprus tax residents in the preceding month.

• INTRASTAT forms are submitted to the VAT Authorities within 10 days from the end of the related month, in electronic form only provided that the supplies of a taxable person exceed the registration

• Payment of tax withheld in the preceding month on payments to non-Cyprus residents.

- The VIES form, is submitted to the VAT Authorities within 15 days from the end of the related month in electronic form only.
