COMMENCEMENT OF THE IMPLEMENTATION OF THE FINAL SOLUTION OF THE ELECTRONIC SYSTEM OF THE BENEFICIAL OWNERSHIP REGISTER

With regards to the above issue, please see below a link of Announcements of the Department of the Registrar of Companies and Intellectual Property (Companies Secton) in relation to the commencement of the implementation of the final solution of the electronic system of the Beneficial Ownership Register as of November 14, 2023. The implementation is divided into three phases:

- (a) The first phase covers the period 14/11/2023-31/12/2023 where all companies and partnerships are required to inform/re-register their Beneficial Owners in the 'Final Solution', even if they have already done so in the interim solution system. Please note that no financial penalties will be imposed during this period.
- (b) The second phase covers the period 1/1/2024-29/2/2024 and requires those companies and partnerships that did not inform/re-register their Beneficial Owners in the "Final Solution" during the previous phase to do so. It is noted that at this stage financial charges will be imposed.
- (c) During the third phase, which covers a period of 1/4/2024 and thereafter, the provisions of Directive K.Δ.Π. 112/2021 as amended enter into force.

SOCIAL INSURANCE RATES INCREASE IN 2024

According to the Social Insurance Law (59(I)2010), as from 1/1/2024 the social insurance contributions rate will increase from 8.3% to 8.8% (instead of 8.9% that was announced before). Employers and employees will be required to contribute an additional 0.5% to the Social Insurance Fund on their insurable earnings.

Self-Employee Social Insurance Contributions in Cyprus

For the self-employed the contribution is 20.5%. Of this percentage, 15.6% is paid by the self-employed person and 4.9% by the Government. In more detail, the contribution rates for the self-employed will change as follows: 21.8%, of which 16.6% is paid by self-employed

and 5.2% by the fixed Fund of the Republic, from the first Monday of 2024.



OBLIGATION TO PAY A FEE 0,4% DUE TO REAL ESTATE TRANSFER AFTER SALE DURING THE PERIOD 22/02/2021-18/11/2022

The Department of Taxation informs that, has sent a notice of the debt of persons who during the period 22/02/2021 to 18/11/2022 transferred immovable property after sale. The relevant notice gives a deadline until 31/12/2023 for payment of the fee without the imposition of monetary charges and interest, as the decision of the Tax Commissioner dated 21/11/2022. After that date, monetary charges and interest will be imposed until full payment.

It should be noted that those who have transferred immovable property after sale during the above period and have not received the relevant debt notice, should either (a) search for the relevant debt at the Tax Portal – "debt Statement" and proceed to payment or (B) visit the local provincial offices of the Tax Department, presenting all the necessary data for settlement of the debt.

Payments are made through the Tax Portal (by internet banking based on the payment reference number or by credit/debit card). On the website of the Tax Department there is a guide for tax payments that you can consult.



PROVIDENT FUND FOR THE CONSTRUCTION INDUSTRY

The law of 2020 for employees in the construction industry obliges all enterprises that are part of the construction industry (individuals and companies) to pay the provident fund for all their employees.

UPCOMING SUBMISSION DEADLINES

By the end of the month

- Payment of tax deducted from employees salary (PAYE) in the preceding month.
- Payment of Special Contribution for Defence (SDC) and contribution to General Health Care System (GHS) withheld on payments of dividends, interest or rents (when the tenant is a company, partnership, the state or local authority) made to Cyprus tax residents in the preceding month.

- Payment of tax withheld in the preceding month on payments to non-Cyprus residents.
- Payment of Social insurance and contribution to General HealthCare System (GHS) deducted from employees emoluments FORM Y.K.A. 2-002.
- INTRASTAT forms are submitted to the VAT Authorities within 10 days from the end of the related month, in electronic form only provided that the supplies of a taxable person exceed the registration threshold for INTRASTAT purposes.
- The VIES form, is submitted to the VAT Authorities within 15 days from the end of the related month in electronic form only.
