## TRANSFER PRICING – INCREASE OF THE THRESHOLDS

On 1st February 2024 the Tax Department announced that the thresholds for Local File requirements (Controlled Transactions) have been increased for the tax year 2022.

Specifically, a Local File must be prepared by taxpayers if their Controlled Transactions exceed (or should have exceeded based on the Arm's Length Principle) the amount of €750,000 per annum in aggregate per category of transactions (sale/purchase of goods, provision/receipt of services, financing transactions, receipt/payment of IP licencing / royalties, etc.).

Further to extensive consultations with various stakeholders, it was agreed to increase the above-mentioned threshold as follows:

- From €750,000 to €5 million for controlled transactions falling under the financing category.
- From €750,000 to €1 million for all other categories of Controlled Transactions, as mentioned above.



## TAX REGISTRATION THROUGH THE TFA-TAX FOR ALL PORTAL

The TAX Department informs you that, from 08 January 2024, the submission of a request for registration in the tax register will only take place electronically through the TFA-Tax for All portal. A prerequisite for applying for registration through TFA is first to create an account on the TFA taxpayer portal.

Upon approval of your registration request, your account on the TFA Portal is activated and automatically linked to your tax ID number (TIC) for which you will be informed via a message to the e-mail address to which you have declared.



## **TAX PORTAL:** PAYMENTS REGARDING THE RENT DEFENSE (0614) AND GESY (0714) WITHHELD ON RENTS PAID

The process of paying for rent defense contributions and for GESY withheld on rents paid has changed for companies. Payments will now have to be made per semester rather than every month as they were until recently.



## THE PROCEDURE FOR REFUND OF THE CHARGES PAID FOR THE **UBO REGISTER HAS BEEN COMPLETED**

The Department of Registrar of Companies, following its announcement dated 31 January 2024, informs that the procedure for refund of the charges paid from 01/01/2024 - 16/01/2024 in relation to the penalties for the UBO Register has been completed. The refund has been made directly to the account of the card with which the original payment was made.

It is recalled that from April 1, 2024 non-compliance will result in the imposition of administrative and other sanctions, in accordance with the provisions of the Prevention and Fight Against Money Laundering Law and the KDP112/21, as amended and in force.

Extension until March 31, 2024 for the registration of beneficial owners of companies in the Electronic Register of the Department of Registrar of companies.



## UPCOMING SUBMISSION DEADLINES

#### By the end of the month

- Payment of tax deducted from employees salary (PAYE) in the preceding month.
- Payment of Special Contribution for Defence (SDC) and contribution to General Health Care System (GHS) withheld on payments of dividends, interest or rents (when the tenant is a company, partnership, the state or local authority) made to Cyprus tax residents in the preceding month.
- Payment of tax withheld in the preceding month on payments to non-Cyprus residents.
- Payment of Social insurance and contribution to General HealthCare System (GHS) deducted from employees emoluments FORM Y.K.A. 2-002.
- INTRASTAT forms are submitted to the VAT Authorities within 10 days from the end of the related month, in electronic form only provided that the supplies of a taxable person exceed the registration threshold for INTRASTAT purposes.
- The VIES form, is submitted to the VAT Authorities within 15 days from the end of the related month in electronic form only.
