It is recalled that, after the passage of a law by the Parliament in December 2024, monetary charges will be

A financial charge of one hundred euros (€100) will be imposed on the first day of the infringement and a further financial charge of fifty euros (€50) for each day of the continuation of the infringement, with a maximum total charge of five thousand euros (€5,000) per company or other legal entity.
