### The Tax department informs that, the submission of the Individual's Income Tax Return for the tax year 2024 has been extended until 30th September 2025 and it can be done through the TAXISnet system at the address <a href="https://taxisnet.mof.gov.cy">https://taxisnet.mof.gov.cy</a>

(TD1) for Individuals for the year 2024

According to a decree of the Council of Ministers (KDP 384/2024), employees, pensioners and self-employed have the obligation to submit an Income Statement for the tax year 2024, whose gross income for the year 2024 exceeds the amount of €19,500 (nineteen thousand five

hundred euros). On the website of the Tax Department <a href="www.mof.gov.cy/tax">www.mof.gov.cy/tax</a>, useful information material has been posted to complete and submit the declaration, under the icon "TAXISnet-Individual Income Statement 2024".

**Provisional Tax 1st instalment for 2025** 

According to the Cyprus Income Tax Law, legal entities and individuals have an obligation to ap-

ply a temporary tax assessment of their expected annual taxable income for the year 2025.

#### The deadlines for the submission and payment of the tax assessment are on or before the following dates:

• Legal entities with taxable income.

1st Instalment -> 31st of July 2025 with effective deadline 31st August 2025

2nd Instalment -> 31st of December 2025 with effective deadline 31st January 2026

Obligation to pay provisional tax, based on their expected annual taxable income for 2025 have all the: • Individuals with taxable incomes other than salaries, pensions, dividends, and interest; and

- If provisional tax payments were made based on an incorrectly calculated yearly taxable profit, then there should be an amendment before the end of the current tax year, 31st December
- 2025. To pay the provisional tax, you must first create the due amount through Tax Portal and

Entities with no taxable income do not have an obligation to pay provisional tax.

Any payments made after the effective deadline will be subject to interest at the current rate of 2,25% per annum (calculated on a completed months basis) plus a 5% penalty on the tax due. An additional penalty of 5% may be imposed by the Tax Department if the tax remains unpaid two

months after the statutory deadline (i.e. for the 1st instalment, the penalty will be imposed from 1 October onwards). Any difference between the actual tax payable and the temporary tax paid for the year 2025 is payable by 1st of August 2026. #### (TD7) to the new system Tax For All (TFA), necessitating a temporary suspension of the Tax Department's computer systems for scheduled upgrades, detailed as follows: **Tax For All (TFA):** 05/07/2025 to 20/07/2025

**Tax Portal:** 05/07/2025 to 06/07/2025 During the above dates, access to both systems and the associated services will not be available.

In accordance with the new legislative requirements, a Withholding Tax and Contribu-

tions Declaration needs to be submitted on a monthly basis. The monthly TD7 is a separate declaration that does not include all the fields contained in the annual TD7. It is a replacement of the PAYE on the Tax Portal. The introduction of monthly declarations for the year 2025 through TFA will commence once the

necessary procedures and checks have been completed. After the transfer of PAYE to TFA, employers will need to retroactively submit all pending monthly declarations starting from January

01

2025 onwards. Once the monthly TD7 is successfully submitted, obligations will be automatically generated.

Corresponding payments can be made via TFA using a credit/debit card or via Internet Banking

or at the counters of banks that offer this service, using the payment reference number from the

TFA system.
